THE HOUSING AUTHORITY OF THE CITY OF FORT LAUDERDALE IS OPENING THE WAITING LIST FOR NORTHWEST GARDENS IV, FAMILY DESIGNATED PROJECT BASED DEVELOPMENT LOCATED AT (1204 NW 8th STREET, FT LAUDERDALE, FL 33311)

Preliminary applications must be completed online beginning Wednesday, November 6, 2024, at 9:00 AM. The applications will be closed after 60 two-bedroom, 50 three-bedroom, 25 four-bedroom and 20 five-bedroom eligible applications have been received.

To be eligible to be placed on the waiting list, the family composition <u>MUST</u> meet the requirements below:

The Head of the Household <u>MUST</u> be 18 years of age or older. The total household annual gross income <u>must not</u> exceed the *very low-income* limits for the appropriate family size as listed in the Income Limits Table appearing at the end of this Public Notice.

If you wish to apply, you will need to login into <u>https://housing.hacfl.com/</u> and follow the application wizard ensuring that you complete <u>all</u> the required fields, or the application will not successfully be submitted at the end.

Pre-Applications WILL BE ACCEPTED ONLINE ONLY.

Pre-Applications must be completed beginning Wednesday, November 6, 2024, at 9:00 AM and ending when 60 two-bedrooms, 50 three-bedroom, 25 four-bedroom and 20 five-bedroom.

Hand delivered or Mailed applications WILL NOT be accepted.
