**Preliminary applications must be completed online beginning July 6, 2026, at 9:00 AM. The applications will close once 100 names have been received for 2 bedrooms, 200 names for 3 bedrooms and 40 names for 4 bedrooms.**

To be eligible to be placed on the waiting list, the Head of the Household **MUST** be 18 years of age or older. The total household annual gross income **must not** exceed the **very low-income** limits for the appropriate family size as listed in the Income Limits Table appearing at the end of this Public Notice.

If you wish to apply, you will need to login to [housing.hacfl.com](http://housing.hacfl.com) and follow the application wizard. Please ensure that you complete **all** the required fields, or the application will not successfully be submitted at the end.

**Pre-Applications WILL BE ACCEPTED ONLINE ONLY.**

**Pre-Applications must be completed beginning Monday, July 6, 2026, and will close once 100 names have been received for 2 bedrooms, 200 names for 3 bedrooms and 40 names for 4 bedrooms.**
